NOTICE: Consent Receipt Specification v1.0 Public Comment and IPR Review Period Now Open

The [Consent Receipt Specification v1.0](#) has recently been approved as a Work Group Draft Specification by the Kantara Consent and Information Sharing Working Group (CISWG), and is now in a 45-day public comment and IPR review period. This is in preparation for a member ballot to consider its approval as a Kantara Initiative Recommendation. We request that you please submit your feedback by February 20, 2017 23:59 PT. UMA 2.0 Updated Specification – Implementers Version Ready for Review in February 2017

The User-Managed Access (UMA) Work Group is pleased to report that its work during 2016 has produced a Version 2.0 specifications draft ([Core revision 10](#) and [Resource Registration revision 03](#) as of this writing) that addresses a variety of new use cases. These include greater OAuth 2.0 and OpenID Connect alignment, greater usefulness for the Internet of Things, applicability to wide ecosystems (where resource owner Alice's systems don't have to establish trust with the systems that Bob uses to prove who he says he is until just before he attempts access to her resources), and more. It's not too late to contribute to this important work! The group anticipates proceeding to a vote for Public Review in early February, and we welcome your participation in spec finalization. If you're not already a WG participant, [Join](#) to get started.
