### 20 **Abstract:**

21 Sally uses a Personal Request for Proposal (pRFP) to solicit offers for, negotiate, and purchase a new car  
22 through the MyPal pRFP Broker. She has previously researched her options and made up her mind about  
23 the kind of car she wants to buy. She has also secured financing and credentials asserting that fact.  
24 Sally's information is maintained in a personal data store, which provides it on demand for use by  
25 service providers and vendors. On the Vendor side, Frank at Chryota of London responds to Sally's  
26 Personal RFP (pRFP), using a hands-on approach that integrates CoL's CRM system, MyPal, and Chryota  
27 Manufacturing's CRM program HEARING AID, which is managed by Jimmy.

28 This engagement model is a detailed expansion of Step #3 of the Information Sharing Work Group's Car  
29 Buying Engagement Model, an instance of the Customer-Supplier Engagement Framework.

30 For consistent context, the events described in this model are presumed to take place in the United  
31 Kingdom.

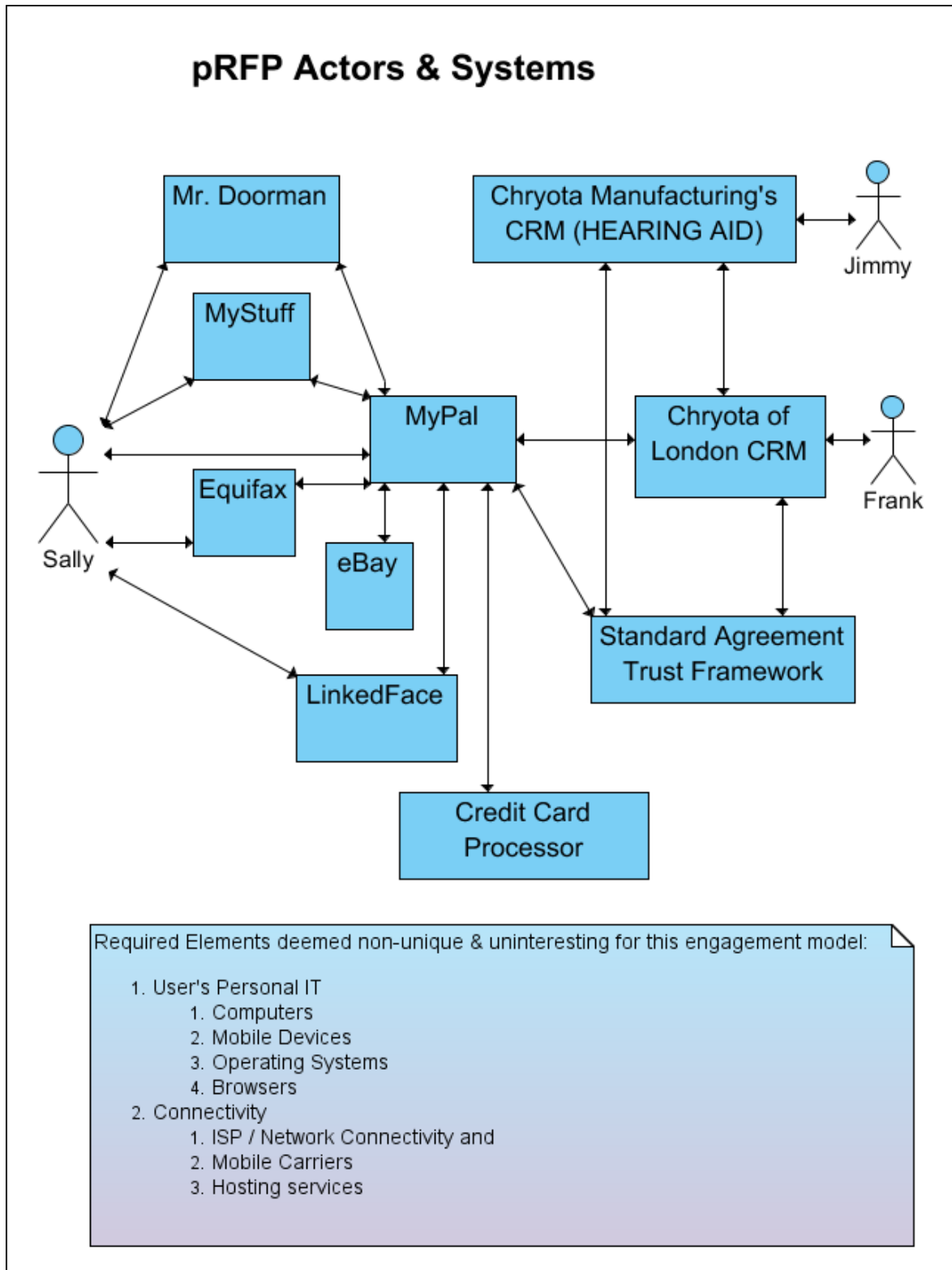

## 85 **Scenario – Sally's Experience**

86 Now that she knows what she wants, Sally fills out a PRFP template using MyPal's mobile phone app.  
87 She pulls in details from her prior research, specifying what she is interested in and how she wants the  
88 conversation to unfold.

89 Sally sets up MyPal as an Authorized Recipient with Mr. Doorman, provisioning MyPal as a pRFP Broker.  
90 She specifies the standard pRFP information use policy, which allows use only for responding to this  
91 pRFP, with long term storage only for quality control and future product and service development. It  
92 also allows authorized recipients not selected in the process to follow up once within the following year  
93 using Sally's protected inbox.

94 Second, Sally specifies what she is interested in and how she wants the conversation to unfold. To  
95 describe what she is looking for, Sally lists:

- 96 1. new 2010 Chryota Prius
- 97 2. enhanced Bose surround sound system (standard factory option)
- 98 3. standard Chryota kids package (car seat, etc.).
- 99 4. no convertible
- 100 5. custom color: Nemo (Clownfish) Orange w/ stripes (semi-structured)
- 101 6. purchase within 1 week
- 102 7. delivery in 2 weeks after purchase
- 103 8. drop off at her home
- 104 9. target price £22,000 (£10,000 cash deposit, balance on delivery)
- 105 10. buyer's financing (credit union loan for balance)
- 106 11. DVLA & Congestion permit paperwork (unstructured)
- 107 12. no Insurance (she already has it)
- 108

109 *This list includes*

- 110 • *Details about the product she wants*
- 111 • *Details about financing, price, and delivery*
- 112 • *Unstructured requests for customization or custom services*

114 *To specify how she wants the conversation to unfold, Sally details who is to receive the pRFP, the terms*  
115 *of use for reviewing the pRFP, and how and when she wants them to communicate with her.*

116 Sally starts building a white list of recipients by searching at MyPal through a list of Authorized Chryota  
117 Dealers within 25 miles of her home, and adds a few from a search of within 50 miles of her sister's. As  
118 she adds the vendors, MyPal presents notice of further distribution, letting Sally know with whom each  
119 Chyota dealer may share the pRFP information, allowing Sally to opt-out if possible. Each of the dealers  
120 lists Chryota Manufacturing, which Sally is ok with. MyPal's interface indicates one or more dealers have  
121 been excluded due to Sally's personal blacklist (as stored in her personal data store). Sally double checks

122 that list and totally agrees: Bob's Chryota is never getting her business again! Based on Sally's searches,  
123 MyPal suggests two additional vendors, one an online car dealer and another a car broker near Sally's  
124 home. Sally decides not to include those two in her recipient list. As she reviews possible recipients,  
125 MyPal displays the reputation information available for each Vendor. Sally drills down on the reputation  
126 details for two of the vendors, using MyPal's tracking data. At this point, she decides not to pay for the  
127 details provided by any of the third party reputation services.

128 When submitting this information, Sally authorizes MyPal, eBay, and Equifax as reputation providers for  
129 this transaction, linking this particular pRFP to Sally's reputation and tells Vendors that this transaction  
130 will be recorded for reputation tracking (of both Sally and the Vendor) at those three services. In  
131 exchange for this tracking information, the reputation providers agree to incorporate this transaction in  
132 future reputation scores and to provide a current reputation score to approved Vendors on a freemium  
133 business model: a simple score for free, details for a fee, while depersonalizing all information presented  
134 to help protect Sally's privacy. Sally also specifies that all questions asked during the pRFP process will be  
135 confidential, as will be their answers.

136 After a final review of the details, Sally tells MyPal to publish the pRFP, selecting the £25 option that will  
137 process offline paperwork, contact legacy vendors who haven't yet registered with MyPal, and host a  
138 protected inbox for communications with vendors. MyPal sends a notice to all of the Vendors on Sally's  
139 recipient list, giving them a way to review the pRFP once they agree to Sally's terms of use. For legacy  
140 vendors, MyPal makes a phone call, letting them know about the pRFP and recommending they sign up  
141 through their relationship with Chryota Manufacturing. Sally receives inquiries from two of the Vendors  
142 through MyPal, to which she replies. In her replies, she specifies that she wants the dealer to login to  
143 view her reply, rather than sending the message in clear text directly to the recipient. She ultimately  
144 receives offers meeting her criteria from three Vendors; those offers are hosted at MyPal.

145 After reviewing the offers, Sally calls Chryota of London and asks some additional questions. She takes  
146 notes on the conversation, which are stored along with the Vendor's offer at MyPal. Sally sends her  
147 husband a link to the offer (provisioning access via MyPal, and specifying her husband's contact service  
148 LinkedFace) and asks what he thinks. He likes it, but doesn't want the proposed audio system,  
149 suggesting a different model, just out from Bose. Sally sends a quick message to the Vendor, through  
150 MyPal, asking for the alternate sound system. The Vendor replies with an updated offer. Sally likes it and  
151 decides to pay £25 for Equifax's detailed reputation history for Chryota of London. She finds a history of  
152 recent transactions as well as reviews from actual customers in her area. Some of the reviews aren't so  
153 glowing, but they seem rare and from the comments, the customer may have been the unreasonable  
154 party.

155 After one last surf around the net to check out her alternatives, Sally makes her decision and commits to  
156 the sale, taking her to Step 4 of the Car Buying Engagement Model.

## 157 **Scenario – Jimmy's & Frank's Experience**

158 *[From this perspective, Jimmy & Frank are combined as a "user" of the pRFP system. We will distinguish*  
159 *between these parties when possible, but the system boundary lies between the combined user and the*  
160 *services comprising the pRFP system]*

161 Frank's CRM system at Chryota of London (CoL) is the first point of contact for Sally's pRFP from MyPal.  
162 Upon receiving the notice of the pRFP, the software automatically evaluates the terms of use, generates  
163 a non-repudiatable proof of acceptance of those terms, and uses proof of acceptance at MyPal to  
164 download the pRFP. The pRFP is recorded in the CoL CRM system as a sales lead and forwarded to the  
165 central Chryota CRM system, which Jimmy sees, in accordance with the permission for further  
166 distribution authorized in the delivery envelope (as per Sally's instructions to MyPal).

167 Given Sally's financial credentials, reputation, and shopping timeframe, her pRFP escalates to the top of  
168 Frank's incoming priority list. He reviews what she is looking for, and his CRM system automatically pulls  
169 up inventory at his dealership that meets all of the automatically verifiable criteria. Frank reviews the  
170 options and considers Sally's special requests. The easy one is the DVLA and permitting for the  
171 congestion charge administrator. His dealership routinely handles these matters for buyers and he's  
172 been looking forward to trying out the new semi-automated system provided by Chryota. He marks that  
173 criteria as met, with a brief note and indicating no price impact. He also connects the pRFP to the  
174 Chryota's paperwork reduction system so that the DVLA and congestion permitting will be handled as  
175 quickly as possible should they win the deal.

176 For the second request, the custom color, Frank picks up his phone and calls his favorite custom paint  
177 shop, asking for a price quote. He gets about two of these every month and the shop loves to work with  
178 the dealership. Within 15 minutes he has a firm, fixed price quote faxed to him from the shop. The fax  
179 isn't printed out. It goes directly into the CRM system, routed to Frank. Frank attaches the digital fax to  
180 the pRFP as an internal supplement (not to be redistributed), marking the criteria met, and entering the  
181 appropriate price impact (based on the shops price plus 10%). Finally, Frank reviews the delivery details  
182 and links the pRFP to their internal delivery scheduler, which confirms a £100 price impact, which is  
183 automatically entered into the pRFP tracking record.

184 Before preparing a final offer, Frank sends an inquiry to Sally asking if the initial £10,000 payment will be  
185 made in cash at the dealer, by personal or cashier's check through the post, by electronic check, or did  
186 she have another idea? The question is entered into the CoL CRM, which forwards it to Chryota's  
187 HEARING AID software and attaches the inquiry to the pRFP and automatically submits the message to  
188 MyPal. Sally's reply the next day clarifies that electronic check would be preferred. The reply is routed  
189 through MyPal to Chryota of London, automatically attached to the customer record, alerting Frank to  
190 the incoming message, and a copy is also sent to Chryota. Frank reads the message and updates the  
191 record with Sally's payment preference.



192 Frank walks over to his supervisor's office, bringing his tablet computer with the pRFP and offer ready  
193 for review. His boss pulls up the pRFP record on his machine, asks a few questions, and electronically  
194 approves the offer. Chryota of London's CRM system packages the offer and sends it to MyPal, which  
195 notifies Sally. CoL also sends a copy of the offer to Chryota's HEARING AID program.

196 Jimmy's dashboard presents a running view of the status of all pRFPs, resulting offers, and finalized  
197 deals, including key analytics and metrics about cost of acquisition, estimated manpower per sale,  
198 margins, and projected time-to-sale. Jimmy keeps on top of these numbers, because he knows their  
199 equivalents in the traditional advertising & sales funnel for Chryota. So far, people are coming in at a  
200 lower cost of acquisition, and apparently further along in the purchasing process, which is resulting in a  
201 rather attractive time-to-sale.

202 Within an hour, Frank gets a call from Sally, routed directly to him based on the phone # she called,  
203 which also pulls up the pRFP record on his computer. Sally asks about the paint shop that would be  
204 doing the work. Frank explains who would be doing it, sharing a story about one of the more memorable  
205 projects from last spring. Sally mentions she's heard horrible things about Mike's paint shop and wanted  
206 to be sure her new car would be well taken care of. Frank is able to assure her and adds a note to the  
207 pRFP that the quality of the paint job is especially important to Sally. Sally thanks him and lets him know  
208 she's probably going to make a decision in the next two days and hangs up. The call is automatically  
209 noted in the Chryota of London CRM system, and propagated up to Chryota's HEARING AID program,  
210 becoming part of the sales funneling on Jimmy's analytic dashboard. Frank writes up a quick summary  
211 of the call and updates the estimates for closing the deal and timeframe. The HEARING AID system not  
212 only combines these estimates for analysis, it also learns how good Frank is at his estimates and adjusts  
213 accordingly, giving the overall numbers the highest possible accuracy.

214 Sally's request for a different sound system is routed directly to the CoL and from there to Chryota's  
215 HEARING AID program. Frank is notified via SMS that he has an incoming pRFP update. He reviews the  
216 request and is surprised, because he hadn't heard about the new sound system from Bose. He asks his  
217 supervisor if knows about it and it is new to him as well. Frank searches online to see what he can find  
218 out, and in fact, Bose just announced the new system today. He pulls up the contact information for the  
219 dealership's Bose representative and calls to ask about the new systems pricing and availability. The rep  
220 gives him the standard dealer rate and confirms he can get the system in to the dealership in two days  
221 from order. Frank requests a confirmed quote, the Bose rep faxes over the details, which, just like the  
222 paint shop quote, get attached to the pRFP and the price impact added. With the new price, Frank  
223 triggers an update on the CoL CRM, which automatically propagates to the HEARING AID program and  
224 the pRFP at MyPal, which notifies Sally.

225 After Sally accepts the latest offer, we move to Step 4, Transact, of the Car Buying Engagement Model.

226 **Narrative – Sally's Experience**

227 Precursor: Sally already introduced MyStuff to Mr. Doorman and stored her Credit Union credentials at  
 228 MyStuff.

## 345 **Glossary**

- 346 1. **Individual** – A natural person, a single human being. *Sally, Jimmy, Frank*

- 347 2. **Authorizing Individual** – An Individual who has shared information with a Receiving Party. *Sally*  
348 3. **Entity** – A corporate person, an individual or individuals operating as a business, a government  
349 agency, or a non-governmental organization (NGO). *Chryota, Chryota of London, DVLA*  
350 4. **Information** – Usable facts or relationships presented in context; data shared for use in a  
351 specific context.  
352 5. **Data** – Information encoded for storage or transmission (may or may not retain context).  
353 6. **Shared Information** – Information voluntarily provided to a Receiving Party under specific terms  
354 of use. *pRFP, vendor blacklist*.  
355 7. **Service Provider** – An individual or entity providing value to other Individuals or Entities through  
356 an interactive system.  
357 8. **Recipient (R)** – A Service Provider that views and uses Shared Information. Also Authorized  
358 Recipient. (The use case doesn't cover unauthorized Recipients) *Chryota, Chryota of London*  
359 9. **pRFP Respondant (R)** – Recipient of a pRFP. To be distinguished from the recipient of a pRFP  
360 Notice because a Respondant must have provided evidence of agreement to the pRFP Terms of  
361 Use.  
362 10. **Facilitator (F)** – A Service Provider that facilitates Information Sharing, but does not itself view  
363 or use the shared information itself. Examples include Data Hosts, Authorization Managers, and  
364 Internet Service Providers. As a litmus test, if the Service Provider could do its job without  
365 decrypting potentially encrypted Shared Information, then it qualifies as a Facilitator with  
366 respect to that information. Whether or not a Facilitator chooses to protect such information  
367 using encryption or other security policies is a business decision of the Facilitator and does not  
368 change its role as Facilitator. For example, quality control, maintenance, debugging, and  
369 customer service are just a few areas where a Facilitator may incidentally have access to the  
370 underlying information without violating its nature as a Facilitator and not a Receiving Party.  
371 *Messages, Inc., Mr. Doorman*.  
372 11. **Hybrid Service Provider** – A Service Provider that acts both as a Facilitator and as a Recipient  
373 depending on the interaction. *MyPal*  
374 12. **Personal Data Store (PDS)** – A distributable repository of information sharable by an individual,  
375 stored at one or more Data Hosts whose access is moderated under the direction of an  
376 Authorizing Individual using an Authorization Manager.  
377 13. **Host (H)** – A Facilitator that stores data on behalf of individuals, for access by Recipients. *MyPal,*  
378 *MyStuff*  
379 14. **Authorization Manager (AM)** – A Facilitator that moderates access to a Host under the  
380 direction of an authorizing individual. *MyPal, Mr. Doorman*  
381 15. **Vendor** – An Entity or Individual offering a product or services "for sale". *Chryota, Chryota of*  
382 *London, Bose, Custom Paint Shop*  
383 16. **Agency** – An Entity providing services to the public, typically governmental or not-for-profit.
